Sensata Technologies comprehensive warranty plan warrants the DSI Series of Low Frequency DC to AC inverters free of manufacturing defects for a full 4 years, including 24 months of the industry leading "Advanced Replacement Program".

Warranty Highlights

• Year 1 & 2: Use of the Advance Replacement Program (A.R.P.)

Advanced Replacement Program (A.R.P.)

- Year 3 & 4 : Return to factory for warranty repair including parts and labor
- ***Please note that this 4 year warranty covers only the DIMENSIONS 12 Volt input inverter models.



Sensata is aware that some inverters, should they fail, could cause hardship for our utility customers. This plan is designed to replace any inverters that are of such critical importance that our utility customers cannot wait the normal one week for a defective inverter to be repaired.

Sensata will ship an advance replacement inverter within two (2) working days of a telephone conversation that confirms that an inverter problem exists. The defective inverter should be returned, to Sensata Technologies, White Bear Lake within two (2) weeks of the installation of the replacement inverter using the same container in which the replacement inverter was shipped. A prepaid return shipping label will be provided for your convenience to return the defective inverter. Sensata reserves the right to bill the ordering party if the inverter is not returned within two (2) weeks.



Note: Advance replacement inverters may be manufactured or refurbished units and have used chassis and covers. The electronic circuits in these units will be the current revision level and the units will be thoroughly tested as complete units before shipping.

Limited Warranty Terms & Conditions

SHIPPING TERMS

F.O.B. St. Paul Minnesota. Freight prepaid and billed, subject to prior credit approval.

MINIMUM ORDER \$50.00 Net Price

LOSS OR DAMAGE

Loss or damage in transit are the responsibility of the carrier. Any claim should be filed with the delivering transport company. Invoice, Bill of Lading and Delivery receipt with damage noted therein must accompany any claims for freight damage. Claims for shortage and lost shipments must be made in writing to Sensata Technologies, Power Controls White Bear, St. Paul, MN within 10 days of date of shipment. Claims not reported within this time frame will not be honored.

PRICES

Prices are subject to change without notice. All orders are subject to acceptance at the factory. We reserve the right to invoice prices in effect at time of shipment.

TFRMS

Net 30 days with approved credit, credit card or C.O.D.

RETURN GOODS POLICY

- · No returned materials will be accepted without an accompanying Returned Materials Authorization Number (RMA) from the factory.
- Credit will be issued for returned goods to the original purchaser within 60 days of purchase, provided the inverter is returned to Sensata unused and not mounted. The amount of credit will be issued at Sensata's discretion based on the condition of the product.
- Customer must be in good standing with Sensata Technologies.
- Inverters that are discontinued, high-voltage (over 24vdc), special-order or used are excluded and will not be eligible for credit. Non-inverter items such as cable assemblies, fuses and fuse holders, will not be eligible for credit
- · Support components supplied by Sensata vendors will be covered under that manufacturer's credit return policy.
- · Customer pays return freight.

LIMITED WARRANTY

Sensata warrants to the original purchaser for use that the goods or any component thereof manufactured by Sensata will be free from defects in workmanship from the date of purchase for the period listed on the product label, provided such goods are installed, maintained and used in accordance with Sensata and the original manufacturer's written instructions.
